Re: Open Forum on “Proposed Establishment of an Independent Insurance Authority”

As you may well aware from the media, the Government has just released a Consultation Paper on the “Proposed Establishment of an Independent Insurance Authority”. This is a very important issue and may have significant impacts on the whole insurance industry in Hong Kong.
